- 7. Fire fighting Equipments/processes
- 8. Sports equipment
- 9. Biometric Artificial Intelligence devices
- 10. Pollution measurement equipment Above list in for illustration purpose , any new products/services can be added /modified by 'Review & Evaluation Committee' formed for the purpose as mentioned

The following process shall be used to draft and publish policies/ regulations, regarding adoption of identified mentioned disruptive technologies/ business models in

Process for evaluation of startups working in disruptive technology/ area

- a. The startup should submit an application to Managing Director Chhattisgarh State Industrial Development Corporation (CSIDC) (draft application in Annexure
- b. CSIDC will review the application submitted for startups working on the identified new/ disruptive areas/ technologies.
- c. For reviewing and evaluation following committee will be formed for each case proposed/submitted by start up, named as 'Review & Evaluation Committee' consisting of following members.
 - 1. Managing Director Chhattisgarh State Industrial Development Corporation
 - 2. Nodal officer appointed for the development of start-up ranking ecosystem
 - 3. Technical and Industry experts for the relevant area

- 4. Academia representatives
- 5. Law /Finance experts
- 6. Prospective user departments/agencies of Govt of Chhattisgarh
- 7. Stakeholders including other similar startups/ MSMEs /present vendors or suppliers shall also be consulted and feedback will be taken
- d. Review & evaluation shall be focused on following agenda (list not exhaustive):-
 - Sector in which Startup/ Entity is operating
 - 2. Present scenario/ Sector landscape
 - 3. Disruptive technology/ business model
 - 4. Long term impact of the technology/ business model of startups working in identified new/disruptive areas/technologies.
 - 5. Area of intervention and support required
- e. CSIDC will invite public comments on identified new/disruptive areas/technologies. The duration for receiving public comments will be 45 days.
- f. After reviewing the received public comments and holding internal discussion the 'Review & Evaluation Committee' shall publish decision on applicability of the product/service offered by start up and its commercial utility in terms of scalable business model with a high potential of employment generation or wealth creation policies/ regulations, regarding adoption of above mentioned disruptive technologies/ business models, in public domain after necessary approvals.
